A homeowner provided two Power Point presentations to the Board. The first of which concerned the Sun Ridge website not being updated as often as necessary, as well as not reflecting the best images of the association, and not having proper contact information for the Board of Trustees. The second Power Point presentation addressed many safety concerns throughout the community. Jeanne Dumbrowski advised that all of these issues will be taken into consideration and addressed as necessary.

A homeowner addressed concerns about children being cut in the kiddie pool due to a scratchy surface. She also spoke of her neighbor's trash can being left outside the front door of her unit. She has spoken to the neighbor, but has been a victim of retaliation. The owner of the trash can will be issued a violation.

Another homeowner also expressed a concern about sharp edges in the pool. However, Mary Alice's experience with the sharp surface was in the large pool near the stairs.
